BORROWING POLICIES

1. Standard loan period for books and videotapes is 2 weeks.
2. Members may borrow one item at a time.
3. Members should use a standard interlibrary loan form for borrowing materials.
4. Borrowing member is financially responsible for loss or damage of materials.
5. Circulation of materials must be conducted via messenger or Federal Express, not via U.S. Mail. Circulation costs are the responsibility of the borrower.
