## **Directions to Prudential Insurance -751 Broad Street Newark**

### **From the West:**

Take **Route 280 East** to **Exit 13 (First Street-Branch Brook Park-UMDNJ-NJIT)**. At Exit, **Make Left onto First Street** North, then **Make First Right onto Orange Street**. Proceed on Orange Street, **Make Right on to University Avenue**. Continue on University Ave. through three traffic lights (passing Raymond Boulevard). **Make Left on Bank Street**; proceed two blocks to Edison ParkFast parking lot located on the corner of Bank & Halsey Streets. Walk east on Bank Street; make Left onto Broad Street to our Main Lobby-751 Broad Street (White Building with blue Prudential Letters). The Security desk will call the Library to let us know you are here.

OR

Take **Route 24 East, Exit at Clinton Avenue**, go straight on Hillside Avenue to Clinton Avenue. **Make Right onto Clinton Avenue**. Proceed to Washington Street, passing Market Street. **Make Right onto Bank Street**; proceed two blocks to Edison ParkFast parking lot located on the corner of Bank & Halsey Streets. **Boulevard and then**, Walk east on Bank Street, make Left onto Broad Street to our Main Lobby-751 Broad Street (White Building with blue Prudential Letters). The Security desk will call the Library to let us know you are here.

### **From the North:**

Take **Garden State Parkway South to Exit 145**. Get on Route 280 East. Take **Route 280 East** to **Exit 13 (First Street-Branch Brook Park-UMDNJ-NJIT)**. At Exit, **Make Left onto First Street** North, then **Make First Right onto Orange Street**. **Make Right on University Avenue**. Continue on University Ave. through three traffic lights (passing Raymond Boulevard). **Make Left on Bank Street**; proceed two blocks to Edison ParkFast parking lot located on the corner of Bank & Halsey Streets. Walk east on Bank Street; make Left onto Broad Street to our Main Lobby-751 Broad Street (White Building with blue Prudential Letters). The Security desk will call the Library to let us know you are here.

### **From the South:**

Take the New Jersey Turnpike North to Exit 13A. Follow signs for North Routes 1 & 9 (Newark). Look for sign for Route 21 North (McCarter Highway). Take Route 21 North (McCarter Highway) approximately 2.3 miles. **Make Left onto Raymond Boulevard**, proceed to University Avenue, **Make Left on University Avenue**. **Make Left onto Bank Street**; proceed two blocks to Edison ParkFast parking lot located on the corner of Bank & Halsey Streets. Walk east on Bank Street; make Left onto Broad Street to our Main Lobby-751 Broad Street (White Building with blue Prudential Letters). The Security desk will call the Library to let us know you are here.
