2008 Application for AALL Chapter Registration Award
AALL Annual Meeting – Portland, OR – July 12-15 2008

Purpose:

Each Annual Meeting, the American Association of Law Libraries underwrites **one free full registration** (\$475.00 value) for a number of chapters on a rotation basis. NJLLA members are eligible for the grant this year. AALL's goal is to provide an enriching experience as the member learns and networks with colleagues from across the country.

Qualifications:

Applicant must be a member of the New Jersey Law Librarians Association and a newer member of the American Association of Law Libraries (joined AALL in 2000 or later.) Prior grant recipients and members of the Grants & Awards Committee are not eligible to apply.

Requirements:

Applications and essays must be received by **April 15, 2008**. Applicants assume full responsibility for assuring that all information needed is received by the deadline. In fairness to others, no late or incomplete applications will be processed. All applicants will be notified of the receipt of their applications and of the committee's decision by **April 28, 2008**. Recipient must submit an article by **August 31, 2008** describing his/her experience at the meeting to be posted on the NJLLA website.

The recipient registers for the annual meeting, indicating program selections and any additional functions that may require an additional fee, includes a check or credit card number to cover payment for *all fees other than Annual Meeting Full Registration*, and submits the registration to AALL as directed with cover memo or copy of NJLLA award letter.
