WATCH CHIEF JUSTICE TANI G. CANTIL SAKAUYE'S OPENING KEYNOTE

Last week more than 1,400 law librarians and legal information professionals gathered in person in Denver for AALL's Annual Meeting to learn from peers and partners in the legal information field. During Sunday's **Opening General Session**, Keynote Speaker Chief Justice Tani G. Cantil-Sakauye delivered an inspiring message on the vital role law libraries play in advancing access to justice and the importance of collaborations to promote a strong judicial system.



During her Q&A with Immediate Past President Diane M. Rodriguez following her keynote address, she discussed the importance of bringing diverse groups of people into conversations and to help make more equitable decisions, which strengthens the justice system, leading to greater access to justice for all.
